



STUDENT PERMISSION FORM and WAIVER AND RELEASE OF LIABILITY

This form must be signed and returned to your child’s teacher by Tuesday, June 11, so that your child may participate in June Jamboree. Failure to return this form will result in your child’s inability to participate in the event’s activities.

The safety of our students is a top priority at Boght Hills School, and reasonable efforts are consistently made to promote safety at all school events. However, participation in school activities, including June Jamboree, may expose students to certain unavoidable, unpredictable, and inherent risks and dangers that no amount of care, caution or instruction can eliminate. These types of risks associated with June Jamboree may include, but are not limited to, those caused by:

- Participation in field games and tug of war competitions; jumping/playing in an inflatable bounce house; activities associated with a carnival-style “dunk tank”; jumping rope; hula hoop activities; dancing; basketball-related games; STEAM activities; football toss; and playing on a swing set;
- Weather conditions and temperature; and
- The physical condition of the participant.

By signing below, the parent/legal guardian of the student participant indicates that he or she: (1) has read and understands all information contained in this waiver and release form; (2) understands, acknowledges and agrees that activities associated with June Jamboree may present risks to the minor participant, including property damage or loss, serious injury, disability or death; and (3) attests that the minor participant is sufficiently physically fit to participate in June Jamboree activities.
